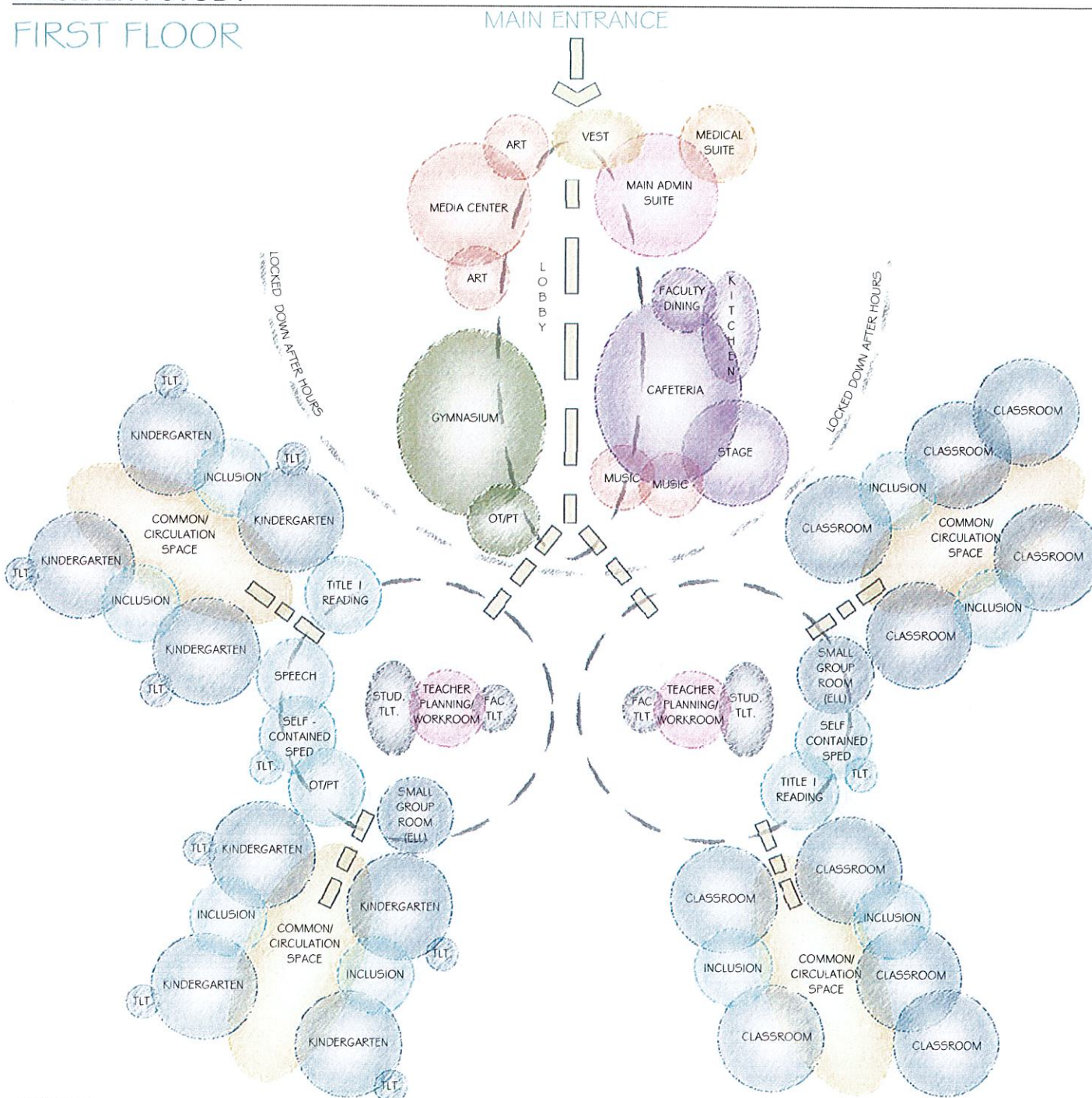

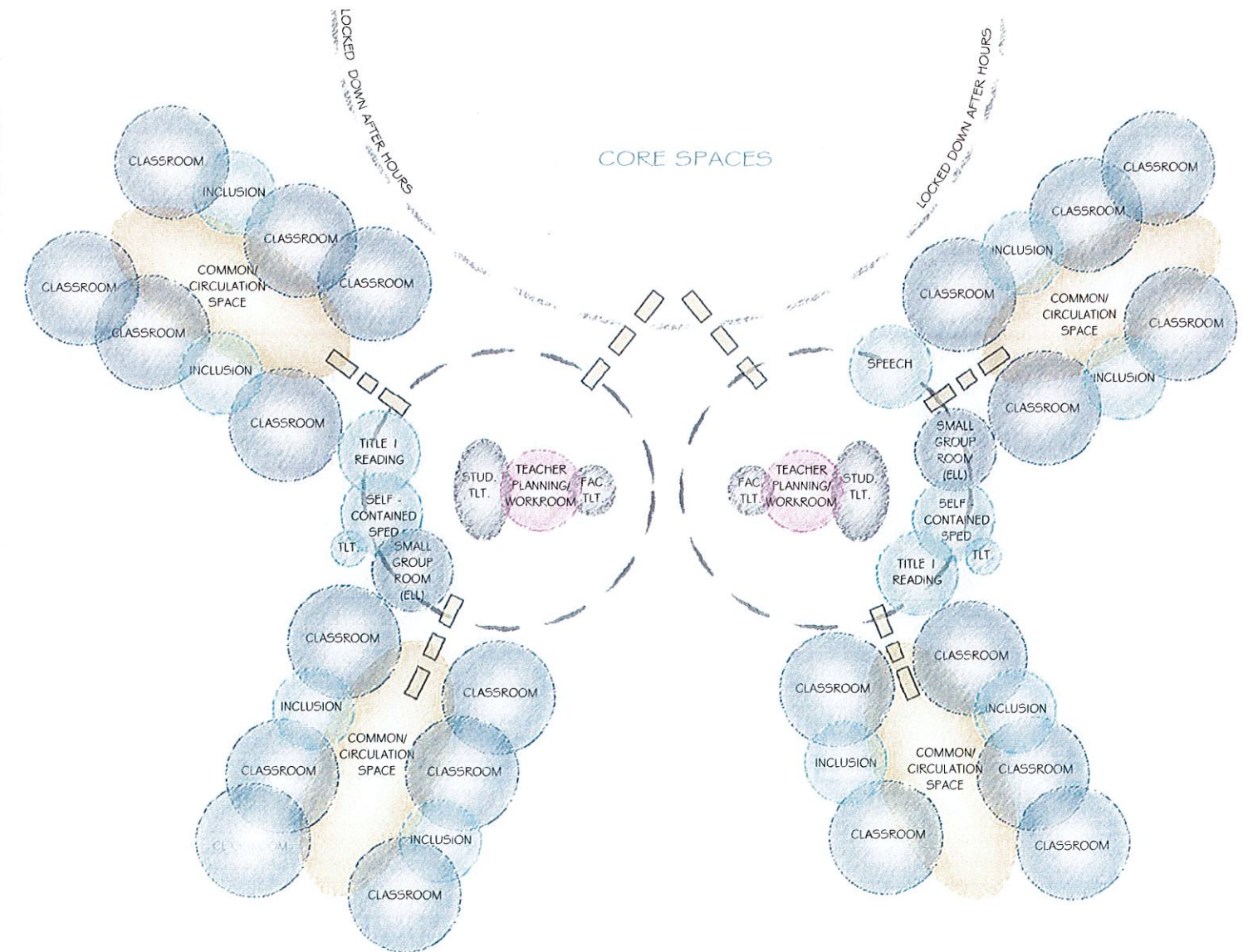
FIRST FLOOR
