On March 12, 2020, Governor Baker issued an Executive Order modifying certain requirements of the Open Meeting Law, to enable public bodies to carry out their responsibilities while adhering to public health recommendations regarding social distancing.

The Executive Order relieves public bodies from the requirement in the Open Meeting Law that meetings be conducted in a public place that is open and physically accessible to the public, provided that the public body makes provision to ensure public access to the deliberations of the public body through adequate, alternative means. "Adequate, alternative means" may include, without limitation, providing public access through telephone, internet, or satellite enabled audio or video conferencing or any other technology that enables the public to clearly follow the proceedings of the public body in real time. A municipal public body that for reasons of economic hardship and despite best efforts is unable to provide alternative means of public access in real time may instead post on its municipal website a full and complete transcript, recording, or other comprehensive record of the proceedings as soon as practicable afterwards.

In addition, all members of a public body may participate in a meeting remotely; the Open Meeting Law's requirement that a quorum of the body and the chair be physically present at the meeting location is suspended.

All other provisions of the Open Meeting Law, such as the requirements regarding posting notice of meetings and creating and maintaining accurate meeting minutes, as well as the limited, enumerated purposes for holding an executive session, remain in effect.

While for this meeting the School Committee and members of the School Department administrative team will physically meet at the location listed above, members of the public may not attend in person. If a member of the public wishes to participate remotely in the Public Participation portion of the meeting, they should contact the Committee Chair, Ms. Sandra Fryc, by sending an email to schoolcommittee@shrewsbury.k12.ma.us.

# Resolution by the Shrewsbury School Committee in Support of the Operational Override "Question 1" on the May 4, 2021 Ballot

The Shrewsbury Board of Selectmen voted unanimously to place the following ballot question before Shrewsbury voters at the May 4, 2021 town election:

#### **QUESTION 1**

Shall the Town of Shrewsbury be allowed to assess an additional \$9,500,000 in real estate and personal property taxes for the purposes of funding municipal and school operating expenses for the fiscal year beginning July first, two thousand twenty one?

A "Yes" vote on this question will be a significant benefit to our town for the following reasons:

- 1) The additional revenue generated for municipal and school operating expenses will address our town's structural deficit problem and will provide financial stability to our town government. This fiscally responsible approach is illustrated by the joint commitments made by the School Committee and Board of Selectmen to exercise fiscal discipline and provide quality services without any additional Proposition 2 ½ override questions for at least the next four years, as illustrated in the Override Statement to the Residents of Shrewsbury.
- 2) The School Department will have sufficient resources to maintain or improve the quality of educational services that our community expects by:
  - a) maintaining current staffing and programming;
  - b) adding the staff necessary to properly open the new Beal School;
  - c) providing tuition-free, full-day kindergarten for all; and
  - d) incrementally restoring positions, programming, and supports that have been cut in previous years.
- 3) Without sufficient local revenue, the school district will need to make major cuts to personnel and programming and will not be able to properly open the new Beal School, which will severely compromise our schools' ability to meet our students' needs at a critical time when they need our strong support. Severely reducing our schools' resources next year will compound the negative effects of the pandemic on our students' well-being and academic progress.

For these reasons, the School Committee strongly encourages all Shrewsbury voters to vote YES on Question 1 at the annual town election, either on May 4th or during the designated Early Voting period. A YES vote will provide our schools with the resources they need to ensure that our town's children receive an excellent education.

Re: Recommendations for Fiscal Year 2022 Fees & Tuitions

At your last meeting on March 24, Mr. Collins presented information regarding fees and tuitions that families pay for various services, programs, or activities that are optional in some manner. At that time, I indicated that I would be making my recommendations for adjustments for your April 7 meeting, and this memorandum contains these recommendations. Please refer to the materials from your March 24 meeting for additional information regarding these fees.

Given that families are being asked to increase their local property tax through the proposed operational override question on the ballot for the May 4 Annual Town Election, I do not believe it is wise to also require an increase in fees or tuitions. As such, my recommendation is to maintain Fiscal Year 2022 fees and tuitions at the rates that were originally established for Fiscal Year 2021, prior to the pandemic. As you know, because of the circumstances of the pandemic, some fees and tuitions were adjusted or eliminated this year, but since we anticipate a more normal situation next school year, it makes sense to return to the established rates in order to offset costs as expected per our budget plan.

The one exception to this recommendation is to <u>eliminate</u> the tuition for full-day kindergarten, in anticipation of the opening of the new Beal School and making good on the commitment to establish tuition-free, full-day kindergarten once the new school provided adequate space for all students to access it. However, if the operational override were to fail at the ballot, I believe the School Committee would need to revisit this and determine whether to maintain some level of tuition given the deep budget cuts that would be required with a "No" vote.

My recommendation is for fees and tuitions to be set at the following rates that were originally established for Fiscal Year 2021 as the rates for Fiscal Year 2022, with the exception of Full-Day Kindergarten tuition:

### **Transportation Fee:**

\$320 per student. The fee would continue to apply to students in grades Kindergarten through Grade 6 who reside two miles or less from their assigned school and to all students in Grades 7-12, with no change to the family cap of three bus fees and the late fee of \$50 per student (with a family cap of three late fees).

#### **Athletic Fees**

Shrewsbury High School: \$325 per sport per season. A family cap of no more than three athletic fees for high school students in the same family per school year would remain in effect.

Oak Middle School: \$100 per sport with a family cap of no more than three athletic fees per Oak family per school year.

A late fee of \$50 for each high school athletics registration and a \$25 late fee for each Oak athletics registration beyond the established deadline for that season.

### **Activity Fees**

Shrewsbury High School: \$110

Oak Middle School: \$75

Sherwood Middle School: \$55

One semester of 14, 30-minute lessons: \$426

This annual report covers the period July 1, 2019 to June 30, 2020. Below are some of the highlights of the priorities addressed during that period:

- Board of Directors voted to approve AVC's leadership team's proposal to adopt a shared leadership model

#### **HISTORY**

The Assabet Valley Collaborative (AVC) was established in 1976.

In Massachusetts, educational collaboratives are public regional multi-service agencies, authorized by state law (Chapter 40, Section 4E) to develop, manage and provide services or programs to public school districts.

According to AVC's founding document, its "Collaborative Agreement," the purpose of Assabet Valley Collaborative is to provide:

- Specialized education programs and services for students ages 3 to 22 and as they transition to adulthood.
- Special education transportation and other transportation services
- Professional development, training and resource sharing
- An array of consultative and direct services
- Cooperative purchasing/procurement services
- Cost-effective responses to needs articulated by member districts
- Services to adults with disabilities subject to authorizing statute, regulations state contracts/approvals and board approval
- Early childhood services to children with disabilities under the age of 3 subject to authorizing statute, regulations state contracts/approvals and board approval

## The overall objectives in AVC's Collaborative Agreement include:

- The creation and/or delivery of cost-effective responses to needs articulated by member districts
- The delivery of high-quality, specialized education programs and services for students ages 3 to 22 and as they transition to adulthood.
- The delivery of cost effective and efficient special education transportation services
- The development and delivery of high-quality and cost-effective consultative services
- The development and delivery of high-quality and cost-effective professional development, training and resource sharing
- The provision of effective and efficient cooperative purchasing/procurement services
- Subject to statutory and regulatory authorization, the development of continuous and evolving services that may include leveraging expertise and resources to expand the continuum of services to include young children with disatilibies and/or adults with disabilities (22+)

#### **BENEFITS OF MEMBERSHIP**

#### 1. Receive member discounts

All AVC programs and services are provided to members at membership rates. Nonmember districts may access AVC programs and services at a 12-15% surcharge.

## 2. Influence and guide decision making

Member districts influence and guide decision-making regarding existing and new programming, improving the quality of services and pooling resources with neighboring districts. In the last decade, member district influence resulted in the opening of SOAR Assessment Center, Evolution, Family Success Partnership, and the expansion of OSA to include grades 5-8 and the addition of music therapy, equity-centered consulting, and a consulting child psychiatrist.

## 3. Obtain cooperative/volume purchasing advantages

Members have access to Cooperative/Volume Purchasing through collective procurement activities. AVC procures goods and services on behalf of member communities, resulting in more competitive pricing for goods districts need to purchase. In FY19 AVC contracts included office supplies, copy paper, school supplies, and transportation services.

#### 4. Gain access to grant-funded initiatives

Members have access to grant-funded initiatives through collective, collaborative stakeholder groups. AVC seeks to identify areas of need and determine grant funding or other sources of revenue to support the launch of new initiatives.

#### 5. Network and Collaborate with Colleagues

Members have access to Job-Alikes and joint initiatives for district faculty. Through joint initiatives, member districts share expertise, pool resources to increase capacity, collaborate on new regulations and mandates, and launch innovations and projects to improve public education in our region.

## PROGRESS IN ACHIEVING PURPOSE

The following table highlight's AVC's progress in 2019-2020 in  $\,$  achieving the purposes articulated in AVC's Collaborative Agreement

Purpose:	Progress in FY20
To provide specialized education programs and services for students ages 3 to 22 and as they transition to adulthood.	AVC continued to provide specialized programs as noted throughout this annual report. Average daily enrollment in specialized education programs in 2020 was: 109. March to June 2020 these services were provided remotely.
To provide special education transportation and other transportation services	AVC transported 485 students in 2019-2020; this was disrupted in March 2020 due to the pandemic.
To provide professional development, training and resource sharing	AVC provided 189 contact hours of professional learning to 422 educators in 2019-2020 until March 2020 when courses and events were canceled. 7 organizations rented AVC's training center 24 days between July 2019 and March 2020. Rentals were canceled after March 12 due to the pandemic.
To provide an array of consultative and direct services	AVC's consulting team provided services to 15 districts/organizations. Family Success Partnership (FSP) delivered wraparound services to 6 districts supporting over 109 students' families.
To provide cooperative purchasing/procurement services	In FY20, AVC conducted joint purchasing for office supplies, copy paper, and school supplies. Bids were collected virtually due to the pandemic.
To provide cost-effective responses to needs articulated by member districts	During 2019-2020, AVC conducted an Equity Audit for a member district; a new service.
To provide services to adults with disabilities subject to authorizing statute, regulations state contracts/approvals and board approval	During 2019-2020, plans to explore adult programming were suspended due to the pandemic.
To provide early childhood services to children with disabilities under the age of 3 subject to authorizing statute, regulations state contracts/approvals and board approval	FSP continues to help families navigate resources related to child care, early intervention, parenting, diapers, nutrition, and other holistic family needs.

### Orchard Street Academy (OSA) and SOAR Assessment Center

Orchard Street Academy offers academic and clinical services to students in grades five through twelve. Programming includes:

- Small instructional groups
- Integration of academics, expressive therapy and transition skills
- Positive Behavior Intervention and Support (PBIS)
- Dialectical Behavior Therapy (DBT) & Trauma-Informed Care (TIC)

Within OSA, SOAR Assessment Center is a short-term stabilization and diagnostic assessment program for middle and high school students (grades 5-12). Our team collaborates closely with parents and districts to identify appropriate academic and clinical supports for students with social/emotional difficulties. Program features include:

- Customized educational and clinical assessments
- Individualized academic and clinical services
- Comprehensive reports and recommendations

#### **Value**

OSA's expressive therapy programs and high-interest electives add value to our comprehensive academic and therapeutic setting. Our educators, clinicians, school psychologists and child psychiatrist support the academic and clinical needs of a wide range of students.

#### REACH

REACH provides a multidisciplinary approach to meet the varied and complex academic, therapeutic and healthcare needs of students with multiple disabilities between the ages of 5-18. REACH infuses social communication throughout programming with a particular emphasis on assistive technology and augmentative communication. Classes include:

- Embedded speech/language, physical, occupational, vision and music therapies
- Comprehensive nursing support
- Inclusion opportunities with typical peers
- Art, cooking, adaptive physical education, music and animal-assisted activities
- Educational and assistive technology

#### **Value**

AVC's REACH program provides a high-quality, cost-effective alternative to enrollment in private schools that are further away from our students' home communities. ### **Transportation**

## Purpose & Value

AVC provides special education transportation services by contracting with a vendor on behalf of our member school districts. Our contract requires vendors to employ well-trained drivers and monitors and that the fleet of vehicles used are well-equipped and maintained. AVC leverages volume from many districts; transportation vendors submit competitive rates to AVC resulting in cost savings for special education transportation. In addition, AVC monitors the quality of the services provided, to save districts valuable time and to capitalize on an economy of scale. While pricing is an important element of the transportation offered, our districts rely on AVC to provide services with vendors who are committed to safe, high-quality and reliable transportation.



Re: EDCO Collaborative Dissolution

As you may be aware, another collaborative - EDCO - is undergoing the process of dissolution. The EDCO Collaborative Board of Directors voted recently to initiate dissolution of their Collaborative due to financial concerns about the organization's viability. The process now requires the school committees of member districts to vote on dissolution.

I am confident the issues leading to this difficult decision at EDCO are not of concern for Assabet Valley Collaborative for the following reasons:

- AVC's Cumulative Surplus as of the June 30, 2020 Audit was \$3,950,431 exceeding the allowable threshold of 25% by \$193,827 which will be disbursed back to member districts by June 30, 2021
- AVC has established an irrevocable OPEB Trust and has been gradually funding the Trust; AVC transferred \$75,000 to the Trust in 2020 and currently has 4 retirees.
- Our current and past annual audits illustrate that we are a solvent organization. Subsequently, we have had no findings for the past several years.
- AVC's revenue has been stable for the past several years resulting in the healthy cumulative surplus
- AVC's property purchases (2 business condominiums at Lord Road) were executed with healthy down payments (together totaling \$648,000) that accelerated equity and favorable mortgage terms.
- AVC does not have debt other than mortgage payments for the Lord Road condominiums as noted above. AVC does not have credit cards.

While AVC has achieved financial stability in the last several years, there are some FY21 vulnerabilities we face that we are actively working to address.

- 1) Finance Director vacancy
  - a) AVC has had a vacancy in the financial leader role since December; after an unsuccessful first effort to fill the position, it was reposted. AVC is contracting with TMS for financial leadership while we undergo a rigorous search process.
- 2) COVID-related revenue loss
  - a) The pandemic has significantly impacted revenue from Transportation, professional development, facilities rentals, and has limited referrals for our programs.
- 3) COVID-related growth deceleration
  - a) AVC had planned to expand services including the opening of an elementary therapeutic school in FY21; this has been postponed.
