**Topic I**

The individuals she requested are not available and she was provided with contact information for Nancy Peace. Ms. Peace is an experienced facilitator in IBB. Dr. Sawyer commented that Wellesley Public Schools used Ms. Peace's services and highly recommend her.

Ms. Malone advised the group that a telephone conference between herself, Ms. Fryc, Ms. Peace, Mr. Chalmers, and another member of the SEA leadership team has been scheduled for November 26, 2018 at 4:00pm.

Dr. Magee inquired into the cost to use an independent consultant versus an individual who is with the Rennie Center. Dr. Sawyer stated that the cost is the same, but the District would enter into an individual contract with Ms. Peace.
