# To Start...

- We care deeply about our environment
- We are not environmental experts

 We are "experts" in our field which is the delivery of public school breakfasts, lunches, and other a la carte items under the <u>highly</u> <u>regulated</u> provisions of the federal and state government.

# To Start...

- Public school food service programs should not be compared to restaurants, higher education food programs, or other institutional food service programs. This is a unique food service program.
- We have:
  - Limited financial resources
  - Limited space
  - Limited timeframes to provide meals to a large quantity of students and staff

# The Petition

### SECTION 2 EFFECTIVE DATE

This bylaw shall take effect on January 1, 2020 to allow time for food establishments and town facilities to use their existing inventory of expanded polystyrene food or beverage containers and to convert to alternative materials.

### SECTION 3 DEFINITIONS

"Disposable Food Service Container" means single-use disposable products for serving or transporting prepared, ready-to-consume food or beverages. This includes but is not limited to plates, cups, bowls, trays and hinged or lidded containers. This definition does not include single-use disposable items such as straws, cup lids, or utensils, nor does it include single-use disposable packaging for unprepared foods. "Food Establishment" means an operation that stores, prepares, packages, serves, vends, or otherwise provides food for human consumption, as further defined in 105 CMR 590.002. Any establishment requiring a permit to operate in accordance with the State Food Code, 105 CMR 590.000, et. seq., shall be considered a Food Establishment for purposes of this bylaw.

"Expanded Polystyrene" (EPS) means polystyrene that has been expanded or "blown" using a gaseous blowing agent into a solid foam. "Polystyrene" means and includes expanded polystyrene which is a thermoplastic petrochemical material utilizing a styrene monomer and processed by any number of techniques including, but not limited to, fusion of polymer spheres (expandable bead polystyrene), injection molding, form molding, and extrusion-blow molding (extruded foam polystyrene). The term "polystyrene" also includes clear or solid polystyrene which is known as "oriented polystyrene".

"Prepared Food" means any food or beverage prepared for consumption on the Food Establishment's premises, using any cooking or food preparation technique. This does not include any raw uncooked meat, fish or eggs unless provided for consumption without further food preparation.

"Town Facility" means any building, structure, land or park owned or operated by the Town of Shrewsbury, its agents and departments. "Town Facility Users" means all persons, societies, associations, organizations or special event promoters who require a permission to use a Town Facility. Town Facility Users also includes concession contracts with the Town, Town-managed concessions, Town-sponsored events and food services provided at the Town's expense.

# The Petition

SECTION 4 PROHIBITION

A. Except as provided herein, Food Establishments are prohibited from dispensing Prepared Food to customers in Disposable Food Service containers made from Expanded Polystyrene.

B. Town Facility Users are prohibited from dispensing Prepared Food to customers in Disposable Food Service containers made from Expanded Polystyrene.

# \*Wheelabrator Millbury

The Wheelabrator Millbury energy-from-• waste facility is capable of producing 45 MW of electricity — enough clean, renewable energy to power 47,000 homes in the Town of Millbury and surrounding Central Massachusetts communities as well as its own operations. The facility uses up to 1,500 tons of everyday waste from homes and businesses each day as a local fuel to create a local-energy ecosystem that generates reliable, renewable energy for the local utility. By using waste materials as a fuel to produce electricity, we offer an environmentally friendly waste disposal option and reduce dependence on landfills.

# Current EPS Styrofoam Use in SPS Cafeterias

- Dishwashers were "mothballed" many years ago in favor of disposable products
- Approximately 425,000 EPS styrofoam trays are used annually
- There is no recycling market for these items
- All disposables are placed into the waste stream and hauled to Wheelabrator for incineration. No Shrewsbury trash is sent to landfills.

# **Current Recycling Efforts**



- Paper
- Cardboard
- Plastic Milk Bottles

# Alternatives If Ban Passes

- 1) Use substitute, non-EPS styrofoam products. They would still enter the waste stream and be sent to Wheelabrator under current waste hauling contract
- 2) Research feasibility of reverting back to
  - "re-useables"
    - plastic/washable trays, plastic drinking cups, and utensils
- 3) Use substitute products and research feasibility of diverting them to a compost/landfill facility

# Alternatives If Ban Passes

 Each of the alternatives comes with <u>increased</u> <u>costs</u> and some options may be neither feasible nor desirable.

# Our Response Plan if Ban Passes

• Use substitute products and pass along cost increase to the "consumers".

 Other alternatives, if feasible, come with significant capital and operating costs for dishwashing equipment, maintenance, chemicals, utilities [water and electricity], and staffing.

# **Non-Price Product Differences**

Styrofoam	Non-EPS Styrofoam Products
Good for either hot or cold food items	Cold products can not be used interchangeably for hot food items
Served as insulators, keeping cold products cold and hot items hot	Products are not insulators so they can be hot to the touch
Products can be stored in wide temperature range without impact.	Clear plastic products are supposed to be stored in a cool environment. Cafeteria storage areas are not climate controlled.

# Summary Impact

- If the EPS styrofoam ban were to pass, then we would recommend a price increase to all meals in the range of \$.10 to \$.20 to cover the cost of substitute products.
  - Current meal prices for lunch are: Elem.=\$3.25, Middle Schools=\$3.50, S.H.S.=\$3.75, Adults=\$4.25
  - Current breakfast price is \$2.00 at all schools
- If passed, the ban does not take effect until January, 2020. So we would have time to conduct further research of products types, quality, and pricing before making any formal recommendation on meal prices.

C. The Health Department or its designee shall have primary responsibility for enforcement of this provision and shall have authority to issue citations for violation(s). The Health Department or its designee is authorized to establish regulations or administrative procedures and to take any and all actions reasonable and necessary to further the purposes of this chapter or to obtain compliance with this chapter, including, but not limited to, inspecting any vendor's premises to verify compliance in accordance with applicable law.

D. The Health Department may enforce this by-law or enjoin violations thereof through any lawful process, and the election of one remedy by the Health Department shall not preclude enforcement through any other lawful means.

E. Penalties and Fines for Violations

Violations of this ordinance may be enforced as follows:

1. This bylaw shall be enforced by the Health Department or its designee, including the Department of Public Works. Whoever violates any provision of this bylaw may be penalized by a non-criminal disposition process as provided in G.L. c.40, §21D and the Town's non-criminal disposition bylaw. If non-criminal disposition is elected, then any person who violates any provision of this bylaw shall be subject to the following penalties:

For the first violation, the Health Department or its designee, upon determination that a violation has occurred, shall issue a written warning notice to the food establishment which will specify the violation and the appropriate penalties in the event of future violations.

Thereafter, the following penalties shall apply:

(a). A fine of one hundred dollars (\$100,00) for the first violation following the issuance of a warning notice.

(b). A fine of two hundred and fifty dollars (\$250.00) for the second and any other violation that occurs following the issuance of a warning notice.

2. Fines are cumulative and each day or portion thereof shall constitute a separate offense. If more than one, each condition violated shall constitute a separate offense.

3. Whoever violates any provision of this bylaw may be penalized by indictment or on complaint brought in the district court. Except as may be otherwise provided by law and as the district court may see fit to impose, the maximum penalty for each violation or offense shall be three hundred dollars

MOTION: I move that the Town adopt the following bylaw regarding the use of expanded polystyrene disposable food and beverage containers by food establishments in the Town of Shrewsbury.

### ARTICLE 8C: EXPANDED POLYSTYRENE BAN IN FOOD ESTABLISHMENTS AND TOWN FACILITIES

#### SECTION 1 PURPOSE AND INTENT

Expanded polystyrene food containers are not recyclable, nor are they biodegradable, and therefore form a significant portion of the solid waste going into our incinerators and landfills; once burned in an incinerator, they contaminate our air, water, soil, food supply, and bodies and once buried in a landfill, they will remain there for centuries. Styrene, the key ingredient in expanded polystyrene, can leach from polystyrene containers into food and beverages and was recently added in 2011 to the U.S. Department of Health and Human Services Report on Carcinogens, a science-based document that identifies chemicals that may put people at increased risk for cancer. Eliminating expanded polystyrene food and beverage containers is in the best interest of the health and welfare of the inhabitants of the Town of Shrewsbury.

### SECTION 2 EFFECTIVE DATE

This bylaw shall take effect on January 1, 2020 to allow time for food establishments and town facilities to use their existing inventory of expanded polystyrene food or beverage containers and to convert to alternative materials.

#### SECTION 3 DEFINITIONS

"Disposable Food Service Container" means single-use disposable products for serving or transporting prepared, ready-to-consume food or beverages. This includes but is not limited to plates, cups, bowls, trays and hinged or lidded containers. This definition does not include single-use disposable items such as straws, cup lids, or utensils, nor does it include single-use disposable packaging for unprepared foods. "Food Establishment" means an operation that stores, prepares, packages, serves, vends, or otherwise provides food for human consumption, as further defined in 105 CMR 590.002. Any establishment requiring a permit to operate in accordance with the State Food Code, 105 CMR 590.000, et. seg., shall be considered a Food Establishment for purposes of this bylaw.

"Expanded Polystyrene" (EPS) means polystyrene that has been expanded or "blown" using a gaseous blowing agent into a solid foam. "Polystyrene" means and includes expanded polystyrene which is a thermoplastic petrochemical material utilizing a styrene monomer and processed by any number of techniques including, but not limited to, fusion of polymer spheres (expandable bead polystyrene), injection molding, form molding, and extrusion-blow molding (extruded foam polystyrene). The term "polystyrene" also includes clear or solid polystyrene which is known as "oriented polystyrene".

"Prepared Food" means any food or beverage prepared for consumption on the Food Establishment's premises, using any cooking or food preparation technique. This does not include any raw uncooked meat, fish or eggs unless provided for consumption without further food preparation.

"Town Facility" means any building, structure, land or park owned or operated by the Town of Shrewsbury, its agents and departments. "Town Facility Users" means all persons, societies, associations, organizations or special event promoters who require a permission to use a Town Facility. Town Facility Users also includes concession contracts with the Town, Town-managed concessions, Town-sponsored events and food services provided at the Town's expense.

#### SECTION 4 PROHIBITION

A. Except as provided herein, Food Establishments are prohibited from dispensing Prepared Food to customers in Disposable Food Service containers made from Expanded Polystyrene.

B. Town Facility Users are prohibited from dispensing Prepared Food to customers in Disposable Food Service containers made from Expanded Polystyrene.

### SECTION 5 DEFERMENTS

A. Upon written application, the Board of Health, after a public hearing, may defer application of this Bylaw for a Food Establishment for a one year period, upon a showing by the Food Establishment that the conditions of this Bylaw would cause undue hardship. For purposes of this Bylaw, an "undue hardship" is a situation unique to the Food Establishment where there are no reasonable alternatives to the use of expanded polystyrene disposable food service containers and compliance with this provision would cause significant economic hardship to that Food Establishment.

B. A Food Establishment granted a deferment by the Town must reapply prior to the end of the one year exemption period and demonstrate continued undue hardship, if it wishes to have the deferment extended. Deferments may only be granted for intervals not to exceed one year.
 C. A deferment granted in accordance with this Section may be extended for no more than one additional one year period, upon written \_\_\_\_\_\_

application to the Board of Health at least two months prior to the expiration of the first deferment period and upon a showing that the circumstances justifying the deferment continue to exist.

D. A deferment application shall include all information necessary for the Town to make its decision, including, but not limited to, documentation showing the factual support for the claimed deferment. The Board of Health may require the applicant to provide additional information to permit it to determine facts regarding the deferment application.

E. The Board of Health may approve the deferment application, in whole or in part, with or without conditions that it deems necessary to protect the public health and further the interests of this Bylaw.

F. Deferment decisions are effective immediately and final.

#### SECTION 6 ENFORCEMENT

A. The Health Department or its designee shall inquire on an annual basis regarding any food establishment's compliance with this bylaw as a condition for renewal of the establishment's food service permit.

B. The Board of Health, after a hearing conducted in accordance with the procedures set forth in 105 CMR 590.14 and 105 CMR 590.15, may suspend or revoke the food service permit for any establishment failing to comply with this bylaw.

C. The Health Department or its designee shall have primary responsibility for enforcement of this provision and shall have authority to issue citations for violation(s). # BACKGROUND INFORMATION:

When approving the recent update to the harassment policy, Committee members suggested reviewing the policy framework that addresses potential staff to student harassment. After consulting with legal counsel and professional resources, the administration recommended to the Policy Subcommittee that it was not advisable to create a separate policy for staff to student harassment in order to avoid narrowing this issue which is covered under the expectations for staff conduct, but that it would be appropriate to update the required policy on the conduct of staff.

Draft policy #321 provides an update that meets the requirements of Massachusetts General Law and articulates the expectations for Shrewsbury Public Schools staff, including but not limited to teachers. It was presented at the meeting on April 25 and has been posted for public review. The draft and current policy are enclosed for reference.

# **Updated Policy – Draft for Consideration**

1. All staff have the responsibility to familiarize themselves with, and abide by, all applicable laws, regulations, and policies set forth by the Unites States of America, the Commonwealth of Massachusetts, the Massachusetts Department of Elementary and Secondary Education, the Shrewsbury School Committee, and the Shrewsbury Public Schools administration (including the superintendent of schools and his/her designees and the school principal and his/her designees), as well as by the provisions of any applicable collective bargaining agreement (e.g., Shrewsbury Education Association, Shrewsbury Paraprofessional Association, etc.).

2. With regard to personal conduct, all Shrewsbury Public Schools staff are expected to conduct themselves at all times in a professional and ethical manner that a) is in keeping with district and school core values and policies, b) reflects positively on the school district and each school, and c) serves as a model worthy of emulation by students.

3. All staff have the responsibility to assist and support both the school district and their assigned school(s) in accomplishing the stated district and school mission, vision, and goals.

4. All instructional staff have the responsibility to help implement locally determined curriculum that is based on the guidelines of the Massachusetts Curriculum Frameworks, and locally determined educational programming, in a manner consistent with each staff member's role.

5. All staff will be provided with a copy of, or an electronic link to, all current applicable regulations and policies; all staff must participate in any mandated compliance trainings related to these, including required state ethics training.

6. A staff member whose conduct violates this policy may be subject to disciplinary action, up to and including dismissal, pursuant to the processes outlined in any applicable collective bargaining agreement or employment contract and/or as set forth in Massachusetts General Laws Chapter 71, Section 42, if applicable.

7. This policy is required by Massachusetts General Laws, Chapter 71, Section 37H.

When questioned, Mr. Moss noted he did not have written materials available but could provide them at a later time.

Katie Crockett and Sean Brennan, Lamoureux Pagano Associates, and Paul Queeney, PMA Consultants, gave the Committee an update on the Beal Building Project that provided detailed information on progress of the Preferred Schematic Report (PSR) phase including: costs associated with the Base Repair option (for benchmarking); photos, diagrams for multiple design schemes; cost comparisons for different construction delivery methodologies; and a site comparison summary for the Glavin Center and Allen Farm properties. The group noted that overall there were more opportunities to develop the Glavin site, and that there was no significant difference financially between the Glavin and Allen locations. Ms. Fryc, who is also a member of the Beal Building Committee (which would meet the following evening to vote on a preferred site and building configuration), requested feedback from the Committee, and Mr. Palitsch and Dr. Magee both expressed a preference for the Glavin site. Dr. Sawyer noted additionally that there was consensus among the educational team that the "L- shaped" option there - which has the cafeteria, gymnasium, and administrative offices on the same floor - works best from an educational program perspective.

V. Curriculum None.

VI. Policy A. District Goals 2018-2020: Vote Dr. Magee advised that these goals, to be completed by the end of 2020, were presented at the April 11 meeting and posted for public review, and that no feedback had been received by the Committee.

On a motion by Mr. Palitsch, seconded by Ms. Fryc, the Committee voted unanimously to approve the District Goals for 2018-2020 as presented.

## B. Regulation of Conduct of Teachers Policy Update: First Reading

Mr. Palitsch, a member of the Policy Subcommittee with Ms. Canzano, noted that when recently approving an update to the harassment policy, Committee members suggested also reviewing policy that addresses potential staff to student harassment. He added that he and Ms. Canzano reviewed the policy draft being presented tonight. Dr. Sawyer advised that based on feedback from legal counsel, administration recommended updating existing policy relative to teacher conduct versus creating a specific staff to student policy, as it might be too narrow in scope. He went on to describe the seven elements of the updated policy and to highlight suggested changes from the existing policy #321. Dr. Magee noted that the new policy would be posted (with changes in red) for public review and comment, and would be voted on at a future meeting.

# VII.Finance & Operations A. Fiscal Year 2019 School Department Appropriated Budget: Vote

Dr. Sawyer and Mr. Collins provided a revised Superintendent's budget recommendation to the Committee in a report that included: budget goals; information on the evolution of the budget; adjustments made since launch of the budget; detailed information on recommended reductions by prioritized tiers (noting Tier 3 reductions were no longer required due to additional revenue allocated to the school department in the Town Manager's Revised Budget Plan); and future concerns including the ongoing structural funding deficit that threatens the quality of the educational program now and going forward.

Committee members expressed their appreciation to the Town Manager's office for additional funding, and shared their concerns regarding ongoing town-wide eroding budget trends and lacking capacity to meet the high expectations of the community.

On a motion by Mr. Palitsch, seconded by Ms. Fryc, the Committee voted unanimously to recommend a Fiscal Year 2019 School Department Appropriated Budget of \$64,137,607 for Town Meeting approval.
