#### 3. Curriculum unit or units related to these trips

This trip will teach the group about creativity, problem solving, teamwork, and communication. The students will interact with other Destination Imagination Teams from around the world who have solved similar challenges. This competition will allow our students to see how there can be many approaches to the same problem and will expand their problem solving skills. They will also meet teams from around the country who are the best teams from their respective state/country and will make new friendships and gain new experience.

### 4. Proposed classroom preparation for the trip and proposed classroom follow up after the trip

The students have designed, built and solved a solution to a Destination Imagination scientific challenge which started late in October 2017. The problem timeframe was from the end of October to the beginning of March. The teams have been meeting multiple times a week throughout the fall and winter, and will continue to meet in spring improving their existing solution and preparing to compete with world class teams.

Our group has learned many new skills for this challenge ranging from creativity techniques, cryptography and steganography techniques, programming, working with electronics, building props, writing a script and directing it, acting, solving a timed challenge and teamwork.

#### 5. Travel plans in detail

- We plan to fly from Boston to Atlanta on Monday, May 22, 2017 via a JetBlue flight.
- On reaching Atlanta in the afternoon, we plan to travel to Knoxville, TN via rented cars. It is approximately 3 hours drive from Atlanta to Knoxville and our team will reach our destination sometime in the evening of May 22, 2017.
- Housing is provided by Destination Imagination and all teams participating in global finals are REQUIRED to stay in DI provided housing. Housing can be either a University of Tennessee dorm room or a hotel provided by DI.
- We plan to stay in DI provided housing from May 22 to May 28, 2017.
- Our return flight to Boston is on May 28, 2017 via a Spirit Airlines flight.

The round trip air tickets cost an additional \$250 per student/manager. In addition, we plan to rent a car from for the week for our round trip from Atlanta to Knoxville that costs \$300 per car.

Total cost breakdown \$775 per student/adult – 4 adults and 7 students = \$8525 Round trip air tickets for 11 members in the team (\$250 per person) = \$2750 Rental car (\$300 per car) – 2 cars = \$600
