Subj: POTENTIAL TRANSPORTATION FEE INCREASES FOR: FISCAL YEAR 2014

<u>Purpose</u>

The purpose of this report is to provide potential options for the district to increase the Transportation Fee for the 2013-2014 school year. The FY 13 Transportation fee is \$250 per student with a \$500 family cap and a late fee of \$50 (\$600 family cap late fee) for payment after June 1. The Transportation Fee went up in FY 10 from \$210 to \$250.

The transportation fees generate additional revenues to aid in reducing amounts expensed to the appropriated budget for these services. For FY 13, we have offset the Transportation line item by \$600,000. The \$600,000 covers approximately 28% of the

The Shrewsbury Public Schools in partnership with the community, will provide students with the skills and knowledge for the 21st century, an appreciation of our democratic tradition, and the desire to continue to learn throughout life.

\$2.1 million dollar regular education busing cost. The fees are used to pay the monthly operating cost of AA Transportation.

Potential Options to Increase the Fee

Option #1 – 12% Increase

The first potential option is to increase the FY 14 Transportation Fee by 12% to \$280.00 per student and increase the family cap to \$560. We would recommend changing the late fee (currently \$50/student) to the following:

Payment received after June 1	\$50.00/ student
Payment received after July 1	\$75.00/ student
Payment received after August 1	\$100.00/student

The staff and contractor spend numerous hours collecting and routing students. The revised late fee structure will encourage families to register earlier and eliminate the last minute changes to bus routes. Families that move to town during the year are not charged a late fee.

Option #2 -20% Increase

Payment received after August 1

The second potential option is to increase the FY 14 Transportation Fee by 20% to \$300.00 per student and increase the family cap to \$600. As above, we would continue to recommend changing the late fee (currently \$50/student) to the following: Payment received after June 1 \$50.00/ student Payment received after July 1 \$75.00/ student

\$100.00/student

Barring unforeseen changes, we project an additional \$60,000 in revenue for option # 1 and an additional \$100,000 for option #2. The additional revenue would continue to go towards offsetting the operating budget transportation line item. The expected total revenue for the FY14 would then be \$660,000 to 700,000 depending upon the option. However, it is possible that there will be a loss of ridership due to families not willing to pay the revised fee.

Family Cap Question

As has been previously discussed, Shrewsbury currently has a family cap of \$500. This covers the cost of two full paying riders. Currently, 124 students qualified for the family cap status in FY13. If these students all paid \$250.00, we would have received an additional \$31,000 in revenue. Does the School Committee wish to eliminate the family cap status for the transportation program?

Other Considerations

The School Department is working on analyzing the impact of reducing bus routes and possible impact on ridership and revenue and will present to the School Committee shortly.
